**Scope 3 Emissions:** includes all other indirect emissions that occur due to an entities activity, e.g. waste produced.

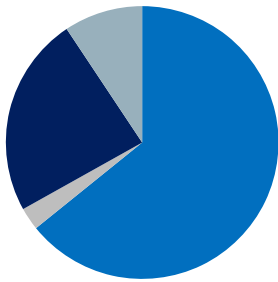
**Scope Other:** emissions not covered in the above, such as transmission and distribution losses.

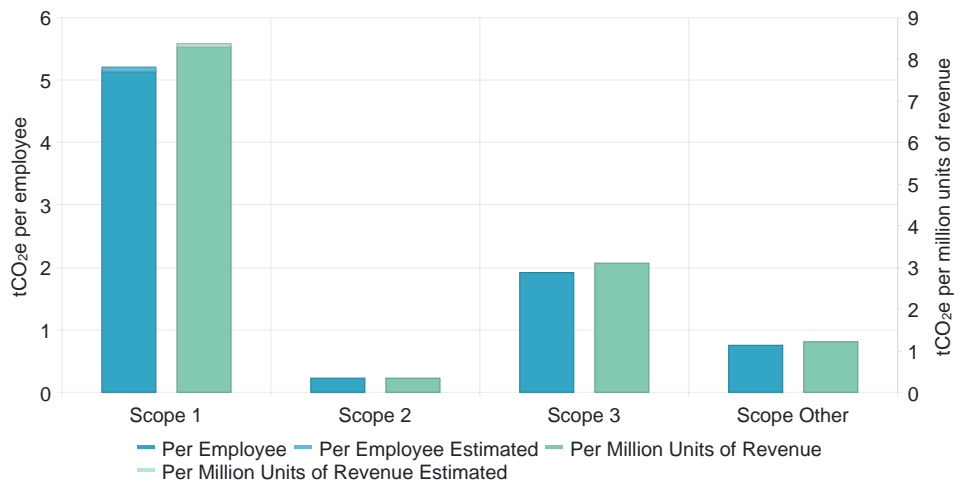

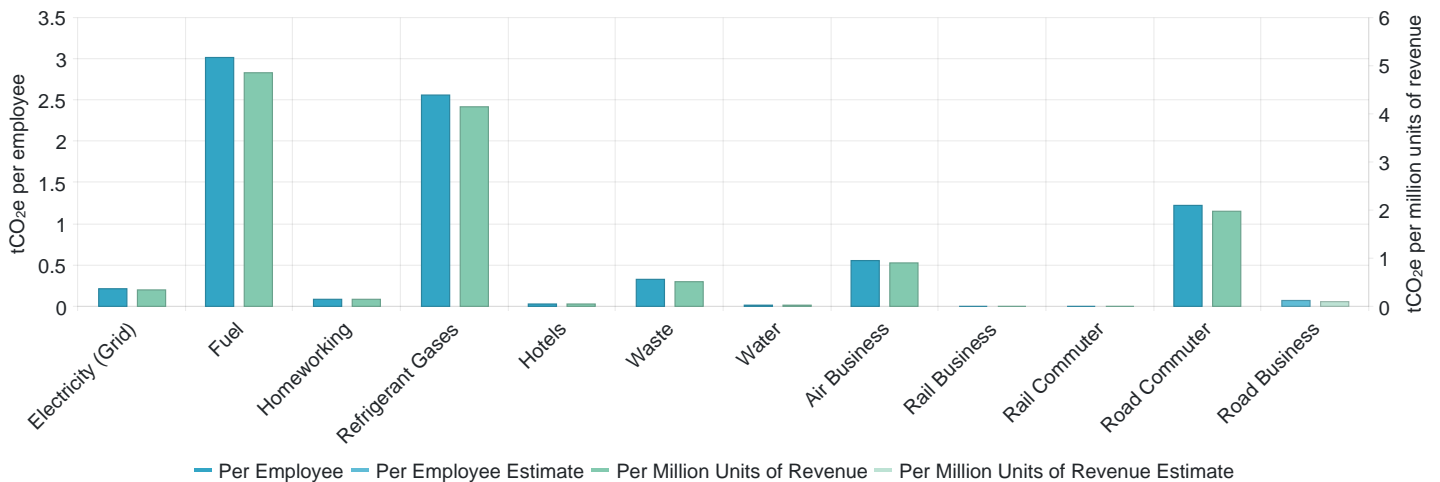

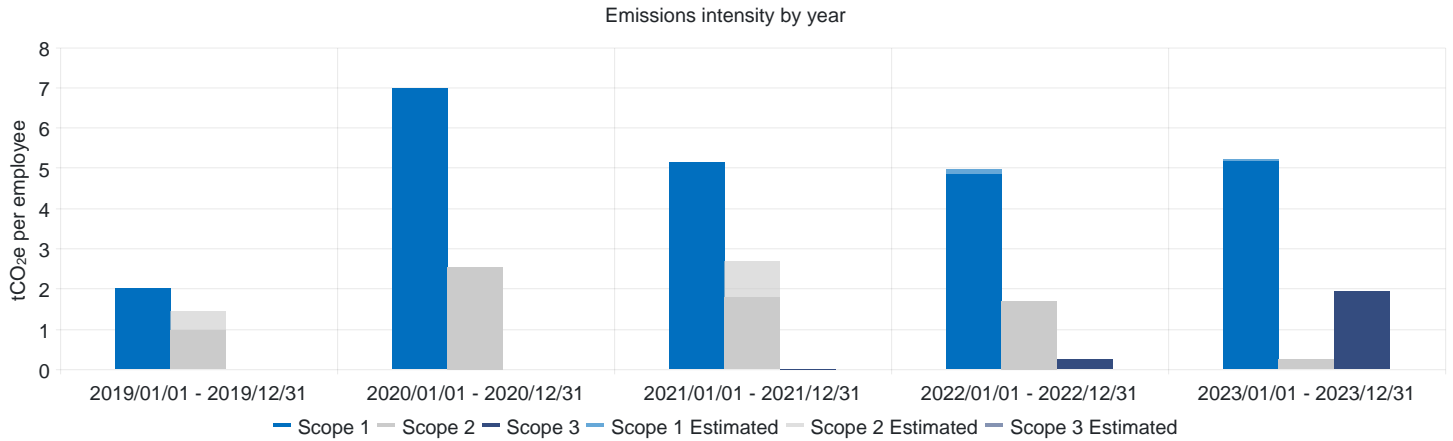
The breakdown below indicates the **emissions intensity by different sources reported and categorized by relevant scope.** Each source of emissions has been normalized by employee and million units of revenue.

Emissions intensity by source based on data provided



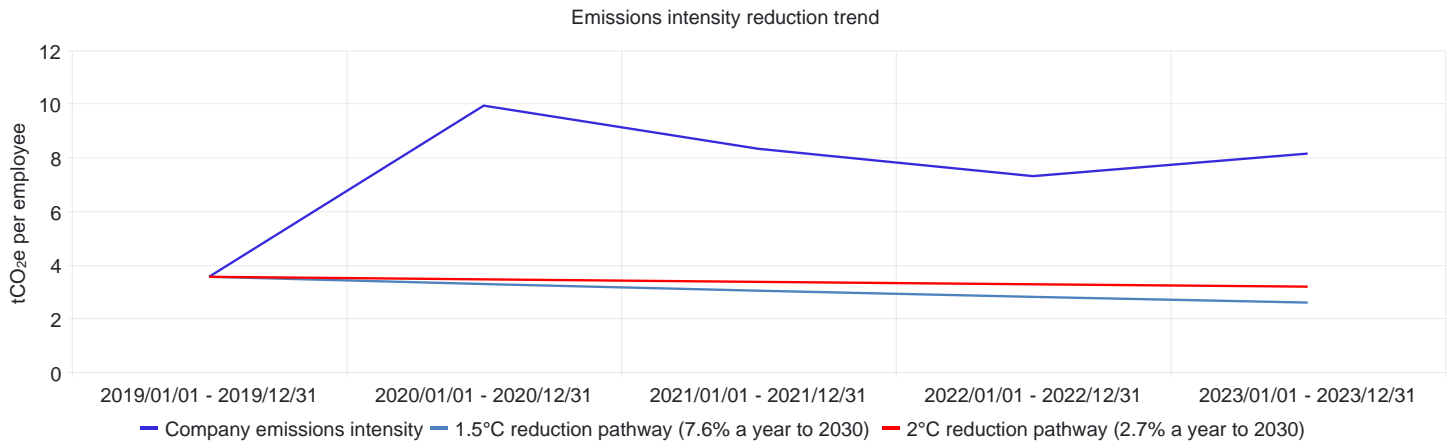
## Emissions Intensity by Scope Over Time

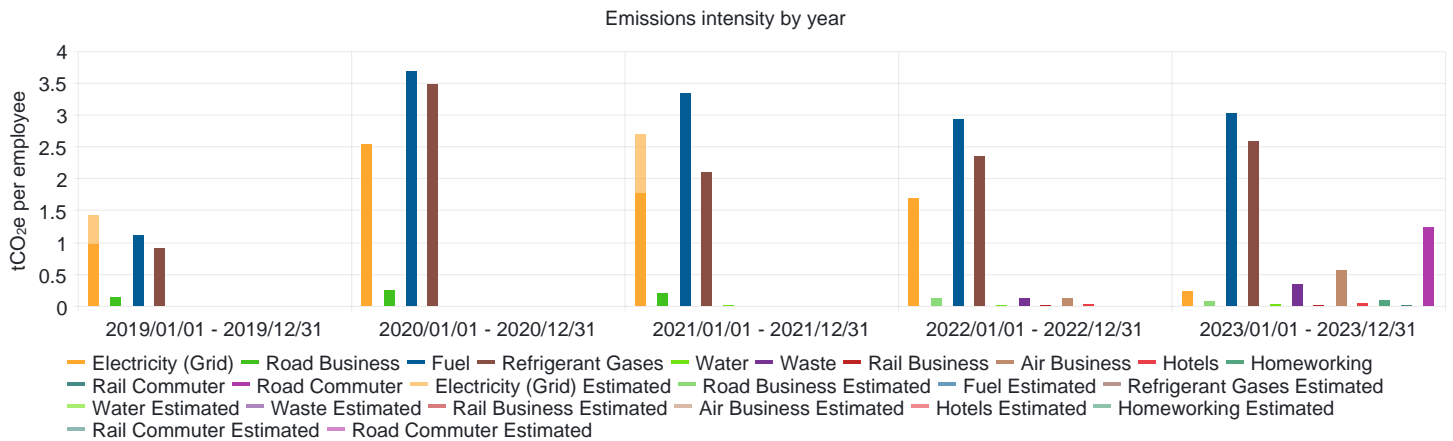
## Emissions Reductions Over Time

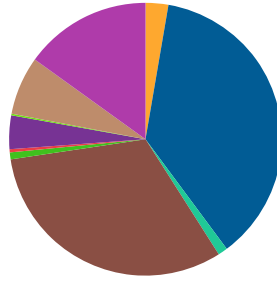
